One option is to buy a dedicated macro lens (the Canon 100mm is a good example) for a few hundred dollars, and that's all you get: a dedicated piece of glass with only one focal length and limited application.

I used a Canon 580EX and the infrared controller that mounts on the camera, but a hot-shoe cord is a lot cheaper and perfectly fine for the small distances you will work in.
